JULY 10, 2024 REGULAR BOARD MEETING

APPROVAL OF AGENDA

Motion by Ward to approve the agenda, second by Lewellen. All in favor. Motion passed.

CONSENT AGENDA

Motion by Ward, second by Taylor to approve consent agenda of past minutes, reports and bills. All in favor. Motion passed.

Under personnel, the Board approved the resignation of Steve Johnson, route bus driver. The Board approved the hiring of personnel for the 24-25 school year as follows: Lori Burton as Math Online Coordinator; Karen Subbert as K-12 PE Teacher for first semester only; Diana Fletchall as Paraeducator; and Laura Bollinger as Paraeducator. Principal Elwood that Jill Isaacson will be the Teacher of Record for Math and Karen Subbert will support the Student Teacher.

SUPERINTENDENT UPDATE

Superintendent Gute gave an update on the progress of the construction projects.

PRINCIPAL UPDATE

An update by Principal Elwood was distributed. It reported on PTSO, Booster Club and student activities. Elwood distributed the ISASP scores, Spring FAST scores and the Conditions for Learning results.

NEW BUSINESS

The Board reviewed proposed changes to the 2024-2025 school year staff handbook.

Motion by Lewellen, second by Taylor to approve the following TLC contracts for the 2024-2025 school year: Rachelle Focht as Elementary STAT/Data Coordinator; Rachelle Focht as Elementary PD Coach; Leanne Johnson as Elementary PD Coach; John Mainquist as Elementary STEM Coach; Kaitlin Allen as Elementary Tech Coach; Lacey Stephens as Secondary STAT/Data Coordinator; Carla Erickson as Secondary PD Coach; Lacey Stephens as Secondary PD Coach; Jeff Grebin as Secondary STEM Coach; Jeff Grebin as Secondary Tech Coach; Leanne Johnson as 1st Grade Mentor Teacher; and Kaitlin Allen as 5th Grade Mentor Teacher. He explained the need and shared that Jody Druivenga has secured a \$5,000 commitment from the Stanton Booster Club to help with the expense. Quotes presented were from DANNCO in the amount of \$9,029, and from Hauff Sports in the amount of \$9,459.50.

Motion by Ward, second by Lewellen to approve the purchase of a volleyball net system from DANNCO in the amount of \$9,029. All in favor. Motion passed.
